(for use with a New Zealand citizen whose Special Category (TY444) visa was cancelled under subsection 501(3A) of the *Migration Act 1958* and who has an un-finalised application for revocation)

I am an unlawful non-citizen and I request that the Department of Immigration and Border Protection (DIBP) remove me from Australia in accordance with s198(1) of the *Migration Act 1958* (the Act), which states that *an officer must remove as soon as reasonably practicable an unlawful non-citizen who asks the Minister, in writing, to be so removed.*
